**ORDER**

In continuation of this office earlier order No. ADM/SOUTH/COVIF-19/Enf.Team/2022/1882 dated 26/04/2022, wherein a notification No. F.51/DGHS/PH-IV/COVID-19/2020/MCD#000597848/prsecyhw/4093-4242 dated 22/04/2022 has been issued from the office of Spl. Secretary (H&FW), GNCT of Delhi, Department of Health and Family Welfare, Delhi Secretariat.

AND WHEREAS, DDMA has noted that the positivity rate of COVID - 19 infection has been increased in Delhi over the past fortnight.

AND WHEREAS, the DDMA after examining all the relevant facts related to the issue of penal provisions for not adhering to covid protocol of wearing of mask at public places, decided that, in relation to the clause 3(h) (c) **whereby not wearing of face mask/cover in all public places has been made an offence, a fine of ₹ 500/- for not wearing of face mask/cover in all public places in Delhi will be imposed. Further, the fine under this provision of the notification will not be applicable to persons travelling together in private four wheeler vehicles.**

NOW THEREFORE, in view of the above, the office of District Magistrate (South) is constituting three (03) Enforcement Teams in Revenue District South, in the supervision of Tehsildars of the concerned Sub-Divisions who will monitor the Enforcement and report on daily basis about figure of Challan issued to the Coordination Branch of District South.

1. First Team constitutes of Sh. Anil Kumar, Tehsildar (Hauz Khas) & Sh. Yogesh Adya along with 15 CDVs.
2. Second Team constitutes of Sh. Sashi Kumar, Tehsildar (Saket) & Sh. Ranga Rajan along with 15 CDVs.
3. Third Team constitutes of Sh. Santosh Kumar, Tehsildar (Mehrauli) & Sh. Surender Meena along with 15 CDVs.



Area jurisdiction of all 3 teams will be within boundary of Revenue District South. All 3 Teams will enforce the direction of the directions of DDMA. All Incharge will work in close coordinate with each other so that issue of overlapping of enforcement area will not be arise.
